

An excerpt from the American Eskimo Dog Club of New England's Show Policies

ENTRY CANCELLATIONS & REFUNDS

1. Entry cancellations must be received in writing prior to the closing of pre-entries or before limits have been reached. Cancellation requests must be mailed to the Event Secretary, or emailed to aedcone@pssweb.net. Requests must include the dogs UKC number, breed, name, and event type entered. Cancellations received by telephone will not be accepted.
2. No refund of entry fees will be made for entries cancelled after the pre-entry closing date, except in the cases of females that come into season and are entered in a performance event. In those cases, refunds may be obtained by providing the Event Secretary with a veterinarian's certificate verifying that the female came into season after the closing date. The certificate may be mailed, provided the **postmark** is no later than the date prior to the day of the event, emailed to Event Secretary, or delivered by hand to the Event Secretary before the start of the event.
3. Cancellations submitted before the close of entries will be charged \$5 per entered class.
4. Entry fees shall not be refunded in the event a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Event Committee.
5. If, because of riots, civil disturbances, or other acts beyond the control of the host organization, it is impossible to open or to complete an event, no refund of entry fees will be made.
6. If, in the opinion of the host club, the well-being of dogs, exhibitors, or spectators is at risk due to extreme weather conditions, such as but not limited to, snow storms, hurricanes, tornados, lightning, flooding, or extreme heat, the host club may cancel or stop an event before completion. No refunds will be made in such cases.
7. Pre-entry fees will be returned (refunded) to the exhibitor should it become necessary to cancel or reschedule the events due to State, County, City restrictions or mandates due to COVID-19. No refunds will be issued for exhibitors who do not attend and have already paid (pre-entered). ~~Day of show entries will not be refunded under any circumstances.~~

ENTRY ELIGIBILITY:

Dogs must be individually registered with the UKC or possess a TL (Temporary Listing) number on the day of the show. No exceptions will be made. Entries for ineligible dogs will be returned. Temporary Listing may be purchased 24/7 directly from UKC at <https://www.ukcdogs.com/tl-numbers>

Dogs must 6 months on the day of the event for Conformation.

ENTRIES: (Pre-Entries close Wednesday, June 16, 2021 or Maximum Limit)

- Conformation Regular & Altered Classes: \$25 per show
Weekend Special Conformation: \$95 same dog all 4 shows
- Junior Showmanship: \$10.00; Pee-Wee, Sub-Junior, Pre-Junior: No Charge
Weekend Special: \$30 Junior all 4 shows

PRE-ENTRY ONLY – NO DAY OF SHOW ENTRIES

[Covid-19 Waiver](#) MUST be signed to exhibit – NO EXCEPTIONS

SUBMITTING ENTRIES

Entries must be submitted on current Official UKC Entry Form which can be download directly from the UKC website and also available on the AEDCONE website under the heading "Forms.". Note: there are separate forms now for Conformation, Junior Showmanship, and Performance Events.

[Covid-19 Waiver](#) form will be emailed to you and should be brought to show to be signed at event prior to receiving armband. Check the AEDCONE website for more details. <https://aedcone.pssweb.net>

Entries received incomplete will not be accepted

Pre-entries may be mail or hand-delivered to the Event Secretary.

Mailed Entries MUST include the entire form, payment and be signed and dated. Mailed entries received without the fees will NOT be accepted.

PAYMENT

Pre-entry payment may be made by check or money order.

Make checks and money orders payable to AEDCONE. Checks and money orders must be payable in U.S. funds.

Post-dated checks and returned checks do not constitute valid entry fees. AEDCONE will add a collection fee of \$30 to the amount of each returned (uttering) check or money order, and additional fees such as, but not limited to USPS certified mailing fees. UKC will be notified immediately when it becomes known (See Misconduct Category 3, pgs 16-17 of *Regulations Governing UKC All-Breed Events & Misconduct* manual). Exhibitors who repeatedly submit invalid entry fees may be put on a cash-only basis.

DIRECTIONS TO THE SHOW

Take Mass. Pike (Route 90) to Exit 3. Turn right off of exit ramp. Take first right onto Arch Rd.

Go about 1 3/4 miles and turn left onto Cabot Rd. Follow Cabot Rd. to end. Turn right onto Russellville Rd. Fairgrounds ahead on right.

For exhibitors attending their first UKC show, here is a brief summary of some of the rules that you should be familiar with. This is for general information purposes, the exact wording of the rules is available in the Conformation Rule Book, and online.

1. Grooming should be kept to a minimum – no foreign substances or excessive grooming is allowed.
2. No grooming or grooming tools in the ring.
3. No bait unless the judge allows it, in which case it must not be thrown, tossed, or land on the ground.
4. No professional handlers.
5. Dogs must be kept under control.
6. Exhibitors are expected to clean up after their dogs.
7. No alcohol or illegal drugs are permitted at a UKC event.
8. UKC events are family-friendly; poor sportsmanship and foul language will not be tolerated.

All dogs need a valid permanent or temporary listing United Kennel Club registration number. Register early for a Permanent Number. For information visit <https://www.ukcdogs.com/registration>. A Temporary Listing (TL) number maybe purchased 24/7 by visiting <https://www.ukcdogs.com/tl-numbers>
